
LOCATION

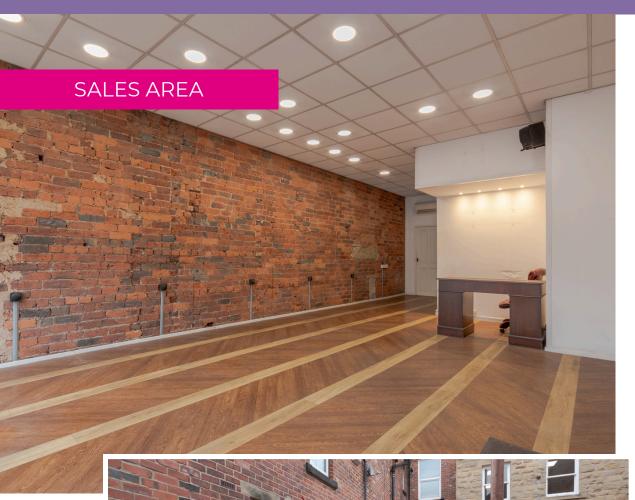
The property is located within the heart of Headingley fronting the busy Otley Road (A660). The property sits on a bus route and is within 1 mile of Headingley train station.

REAR ACCESS

DESCRIPTION

The property comprises a three storey, stone build building under a pitched roof whereby the ground floor and basement is available.

Internally, the ground floor space is open plan and presents well with its exposed brick wall. The whole of the ground floor benefits from a suspended ceiling with a number of spotlights throughout. At the rear left, there is a WC.

At the rear is also access to the basement. This basement is ideal for storage and also benefits from a WC.

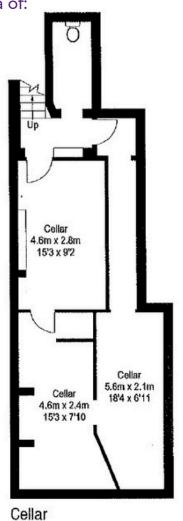
The property benefits from a second access point whereby there is a rear door. This door leads to a space behind the property which could be used as a car parking space.

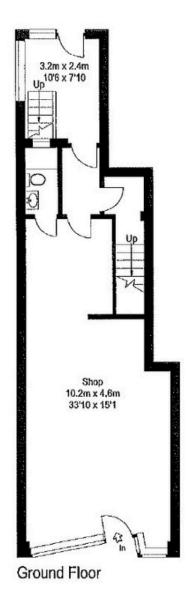
